As of May 19, 2020, the Reporting Persons Conestoga Capital Advisors indirectly beneficially owned 2,439,155 shares while the Conestoga Small Cap Fund owned 1,343,353 of the 2,439,155 of the Issuers Common Stock indirectly beneficially owned by Conestoga Capital Advisors. Such shares of the Issuers Common Stock were directly beneficially owned by the Accounts. The Conestoga Small Cap Fund beneficially owned more than 5.0% of the Issuers issued and outstanding Common Stock.
